



**OFFICIAL CALL
Mass Meeting

As Chairman of the Hanover County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jack Dyer, do hereby issue this call for a **Mass Meeting to be held at Hanover County Administration Building, 7516 County Complex Rd., Hanover, VA., starting at 6:30 PM local time on Monday, September 21, 2026** for the following purposes:

- a) Elect up to 290 Delegates and an equal number of Alternates to the Republican Party of Virginia 5th Congressional District Convention [2026-Fifth-District-Convention-Call-3.pdf](#) to be held on November 14, 2026, at 10:00 AM at the Thomas Gymnasium, Fork Union Military Academy, 4744 James Madison Hwy, Fork Union, VA 23055 or an alternate site if necessary. The purpose of the Convention is:
 - a. Election of Fifth District Republican Committee Chairman,
 - b. Transaction of such other business as may properly come before the Convention

Qualifications for Participation

All legal and qualified voters of Hanover County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

All individuals desiring to participate in the party canvass shall be required to present some form of photo identification such as a valid driver's license, or other positive identification.

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions, as defined in Article I of the Party Plan of the Republican Party of Virginia, for a period of four (4) years.

A person otherwise qualified shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter.

Filing Requirements

Candidates for election as Delegates (and Alternates) to the November 14th Congressional District Convention must submit the 5th District specific filing form that can be found below or on the HCRC website [2026-Fifth-District-Delegate-Filing-Form.pdf](#) and fee by mail or in person to **HCRC Treasurer, PO Box 6617, Glen Allen VA 23058 or 14168 Windmill Dr., Montpelier VA 23192** no later than **September 14, 2026 at 5:00 PM. Postmarks do not govern.**

If the number of delegate candidates filed do not exceed the maximum numbers allowed for their respective positions, all properly filed candidates meeting the foregoing requirements for member and delegate may be declared as elected.

Registration Fees

There is no HCRC registration fee to participate in this Mass Meeting.

For the 5th District Convention, a fee of Twenty dollars (\$20) to help cover the Convention expenses is required of each person standing for election as a delegate or alternate delegate to the 5th District Convention.

Cancellation / Alternate Date or Location

Should no more than 290 delegates pre-file by the deadline, then those candidates shall be duly elected, and the mass meeting shall be cancelled. The Chairman of the Hanover County Republican Committee may move the Mass Meeting to an alternate location, date and time upon significant hazard or unavailability of the primary location, date and time.
